HEALTH INSURANCE

International students are required to enroll in LWTech's health insurance program. A student may opt out of LWTech's health insurance if:

- the student's parent or spouse is employed in the U.S. and has insurance through their employer and the student is included in their policy
- the student has coverage from an insurance provider from their home country or an embassy sponsored plan and a summary of benefits that explains in English the insurance benefits and full dates of coverage (the insurance coverage must be comparable to LWTech's health insurance benefits)

In order to opt out, the student must bring: 1) a copy of the insurance card; 2) copy of the insurance benefits. International Programs will make the final decision whether a student is qualified to opt out of LWTech's health insurance program.
